The Poverty Tables provide condensed poverty profiles cross-tabulate poverty by a number of dimensions: age, education, occupation, labour force status, gender, family status, visible minority status, aboriginal status, ethnicity, immigration, language, disabilities, and mobility. From the income tax forms submitted each year by Canadians, the Small Area & Administrative Data Division produces a wealth of economic and demographic information for use by both the private and public sectors. Commonly referred to as "taxfiler data", over 20 million records are processed each year to provide the most detailed and accurate date possible. In fact, the information represents approximately 96% of the Canadian population. These data are matched to a number of geographic files giving clients the opportunity to request data for areas as small as a letter carrier's walk. Sample extract from the Family Data Bank:

9) SURVEY OF HOUSEHOLD SPENDING (annual data – 2006 through to 2010)

by Canada, Provinces/Territories, and Selected Census Metropolitan Areas

These tables present average expenditure per household, percentage reporting, average expenditure per household reporting, and percentage of total expenditure for detailed expenditure categories.

<u>Expenditure categories</u> include: shelter expenses, furnishings and equipment, cost of running the home, communications, child care, food, alcohol and tobacco products, clothing, gifts, medical and health care, transportation and travel, recreation, reading materials, education, taxes, insurance payments and pension contributions.

<u>Dwelling characteristics</u> include: type of dwelling, repairs needed (major, minor, none), tenure, year of move, period of construction, number of rooms, number of bathrooms, principal heating equipment and fuel, age of principal heating equipment, principal heating fuel for hot water, and principal cooking fuel.

<u>Household equipment</u> includes: washing machines, dryers, dishwashers, refrigerators, freezers, air conditioners, telephones, cellular phones, compact disc players, cablevision, video cassette recorders, computers, modems, internet use from home, televisions, and vehicles.

Characteristics of the household, reference person, and spouse of reference person are also provided.

Commonly referred to as "SLID data", this data includes cross-classified income tables. Tables include income distributions and inequality, earnings of men and women, income tax, government transfers, low income and sources of income.

12) CANADIAN CRIME STATISTICS (annual data – 2006 through to 2010) by Canada, Census Metropolitan Area and City

Tables examine the characteristics of victims and the accused (their age and sex, the relationship of the accused to the victim, level of injury and weapon causing injury), as well as the criminal incident itself (location, target of violation, presence of weapons and type of property stolen).
