Discussion on Change in Procedures for Custom Geographies for future rounds

**Action**: We will prepare a Briefing Note with options for discussion at the Annual Meeting.

Include in the briefing note a list of custom geos that have been used to date. Include the list of

communities that have requested custom geos.

- Proposal 1: Leads take the lead in working directly with STC to complete their geocoding (CCSD took the lead over the past 2 years).
- Leads would seek reimbursement from CCSD for the cost of the geo-coding.
- Proposal 2: We may want to cap the amount CCSD covers based on the size of each consortium. This is a question for other leads to be discussed at the annual meeting.
- CCSD takes the lead in ordering thematic tables using the completed geocoded boundary files.
