<ul style="list-style-type: none"> • Include in a newsletter a summary of the STC webinar that confirmed significant and measurable impact of COVID benefits on 2020 incomes, and resulting outlier impact on deflating poverty and core housing need measures. Emphasize the importance of treating 2020 income-related data with caution, especially for younger and lower income persons. Encourage members to consider the 2021 T1FF income and LIM measures expected to be released this summer. 	MD
