Standard table requests

With the end of the program year in sight, and custom tabulations taking a long time to produce, it's worthwhile considering if there are any standard table requests that could fill out the budget.

ACTION: check with STC if standard tables at custom geos are appropriate for quick turnaround

UPDATE: STC can produce custom tables at custom geos, so long as the custom table has already been created. I have asked STC to continue to produce our custom tabulations at custom geos – namely the remaining HH TGPs and the Census Working Poor table (once it has been produced).

Along the same lines, these are products that were tagged "Low priority", but which could be acquired if there is space in the budget :

- TransUnion 2020Q1 mortgage debt and NMCD
- Canadian Index of Multiple Deprivation (CIMD) acquire this late this year or early next year

NOTE: considerable support was shown for acquiring CIMD

UPDATE: CIMD has been ordered. An estimated delivery date has not yet been provided.

Canadian Community Health Survey (CCHS) Public Use Microdata File (PUMF) data sets

The recent releases of the CCHS PUMF do not include data in IVT format, making it more difficult to extract data sets. The CDP team has received a couple requests to pull out data on food insecurity. Are there any other data sets of interest?

<u>CMHC – CDP data sharing agreement</u>

Priority areas that have been identified include standard and custom geography tables from these sources:

- New Housing Construction
- Rental Market Survey
- Core Housing Need
- Social and Affordable Housing Survey
- Secondary Rental Market Survey

• National Housing Strategy

Calgary request: Market information received more frequently than annually, with quick turnaround, otherwise of less value (new housing, rental market, etc. – more details to follow)

Request from CMHC re: the Social and Affordable Housing Survey

We appreciate your data advocacy efforts and any help you can provide us to reinforce the participation of CDP members in our Social and Affordable Housing Survey - Rental Structures.

The Social & Affordable Housing Survey – Rental Structures (SAHS-RS) is an initiative supported by the National Housing Strategy to portray the social housing stock in Canada and better understand its evolution. Data collected include the number of units by bedroom size per centre, the physical characteristics of the buildings, average monthly rents, type of rent/rent program (e.g. rent-gear-to-income or rent set against market), services provided in the building, general clientele/target groups, etc.

We are currently conducting the second annual survey ("second cycle") out of a planned 10 year survey horizon. The data collection period by phone and other electronic means should continue until then end of March 2021 for the small-to-medium portfolios, while it might be extended in April for the larger ones (like Provinces, Territories, Large Municipalities, Co-op Associations, etc.). Attaining the highest response rates possible across the country is essential for our ability to release results at the centre level (maybe even at finer geography levels) with high statistical reliability. Such results will allow policy makers to take the appropriate decisions in order to improve the housing conditions of all Canadians.

iCARE data to be released by the IMDB group at STC
