## Schedule B, 2016-2017 – Appendix 3

### **Custom geographies for standard T1FF tables**

We will collect custom geographies, typically in the form of shapefiles, from consortium members throughout the Summer of 2016 and into the Fall. Statistics Canada is working on a cost and time estimate to geocode all of the custom geographies currently on file for the Community Data Program. When this first batch of custom geographies has been geocoded to Postal Geography, we will proceed with an order of selected T1FF data tables using these geographies.

Several consortia will not have their custom geographies geocoded before the first data order is submitted. We will continue to collect custom geographies for Statistics Canada to geocode and then submit subsequent orders in batches. CDP members have the option to submit their custom geographies directly to Statistics Canada for geocoding and the Community Data Program will reimburse the geocoding costs.

We estimate that the program can afford to purchase 5 to 10 tables. The Data Purchase and Access Working Group will determine which standard tables to order at these custom geographies. A discussion of this issue is featured in the notes of the [2016 Annual Meeting](#).
